FIRST ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF DREWTINA PROPERTIES VI, LLC (A Florida Limited Liability Company)

Pursuant to Section 608.411, Florida Stanutes, DREWTINA PROPERTIES VI, LLC, a Florida limited liability company (the "Company"), hereby adopts the following amendment to its Articles of Organization:

FIRST:

SECOND:
