**FIRST ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
DREWTINA PROPERTIES VI, LLC  
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **DREWTINA PROPERTIES VI, LLC**, a Florida limited liability company (the "**Company**"), hereby adopts the following amendment to its Articles of Organization:

**FIRST:** The Articles of Organization were filed on November 17, 2005 and assigned document number L05000111356.

**SECOND:** Article II of said Articles of Organization is hereby amended in its entirety to change the mailing and street address of the Company from "6881 Kingspointe Parkway, Orlando, Florida 32819" to a mailing and street address of "8130 Firenze Boulevard, Orlando, Florida 32836", by deleting the provision of said Article II as the same now exists and by substituting in lieu thereof, the following:

**"ARTICLE II - ADDRESS"**

The mailing and street address of the principal office of the Company is 8130 Firenze Boulevard, Orlando, Florida 32836."

**THIRD:** Article III of said Articles of Organization is hereby amended to change the registered office of the Company from "6881 Kingspointe Parkway, Orlando, Florida 32819" to "8130 Firenze Boulevard, Orlando, Florida 32836", by deleting the provision of said Article III as the same now exists and by substituting in lieu thereof, the following:

**"ARTICLE III - REGISTERED OFFICE AND AGENT"**

The street address of the registered office of the Company is 515 East Park Avenue, Tallahassee, FL 32301, and the name of the registered agent of the Company at that address is CorpDirect Agents, Inc."

**FOURTH:** The Articles of Organization are hereby further amended by adding new Article IV to read as follows:
