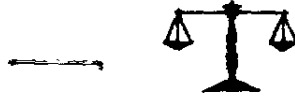

The undersigned officer of the company described herein hereby submits the following amendment to the company's Articles of Organization to the Florida Department of State, Corporate Division.


1. The date of organization of the company is November 14, 2005.
