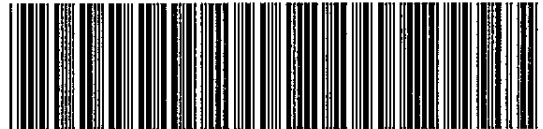

**ARTICLES OF ORGANIZATION  
OF  
JAYHAWK HLS, LLC**

The undersigned, for the purpose of forming a multi member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **JAYHAWK HLS, LLC** ("Company").

**ARTICLE II -- ADDRESS**

The street address of the principal office of the company shall be 187 Hibiscus Road, Edgewater, Florida 32141 and the mailing address is the same.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the company in the State of Florida is James P. Doolin, III, at 187 Hibiscus Road, Edgewater, Florida 32141.

**ARTICLE V -- CAPITAL CONTRIBUTIONS**

The members of the company shall contribute all of the capital of the company in cash or property.

**ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS**

The members shall make additional capital contributions to the company as the members determine necessary.

**ARTICLE VII -- ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the company except with the written consent of the members of the company and on such terms and conditions as shall be determined by the members. The members may transfer their interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless the member of the company proposing to dispose of its interest approves of the proposed transfer by written consent.






