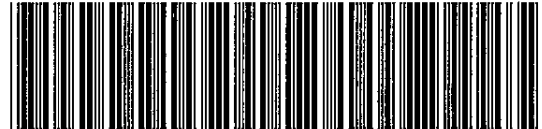

**MANAGEMENT**




