


The undersigned, being the sole Manager and Member of LAVA GROUP, L.L.C. accordance with Sections 608.411 of the Florida Limited Liability Company Act, certifies that:

- 1. The name of the limited liability company is LAVA GROUP, L.L.C. (the "Company").
- 2. The Articles of Organization were originally filed on November 22, 2005 under the name LAVA GROUP, L.L.C., document number L05000112601.
- 3. Article I of the Articles of Organization is hereby amended by changing the name of the Company to : **DEMAR VENTURES, LLC.**
- 4. Article V of the Articles of Organization is hereby amended by striking out Article V in its entirety, and substituting in lieu thereof the new Article V as follows:
