The undersigned, being the sole Manager and Member of **LAVA GROUP, L.L.C.**, in accordance with Sections 608.411 of the Florida Limited Liability Company Act, certifies that:

1. The name of the limited liability company is **LAVA GROUP, L.L.C.** (the "Company").
2. The Articles of Organization were originally filed on November 22, 2005 under the name **LAVA GROUP, L.L.C.**, document number L05000112601.
3. Article I of the Articles of Organization is hereby amended by changing the name of the Company to : **DEMAR VENTURES, LLC.**
4. Article V of the Articles of Organization is hereby amended by striking out Article V in its entirety, and substituting in lieu thereof the new Article V as follows:

"Article V. Membership. The addition of new members shall be governed by the terms of the Operating Agreement executed by and among the members, as may be amended from time to time."

5. Article VII. Management. Article VII of the Articles of Organization is hereby amended by striking out Article VII in its entirety, and substituting in lieu thereof the new Article VII as follows:

"Article VII. Management. The Company is to be managed by one or more managers, the number thereof and election of which, shall be governed by the terms of the Operating Agreement executed by and among the members, as may be amended from time to time."
