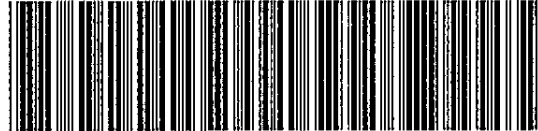

## ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE I -- NAME

## **ARTICLE VI -- MANAGEMENT**



## **ARTICLE VII -- RESIDENT AGENT ACCEPTANCE**

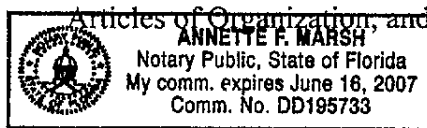



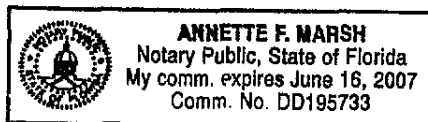
