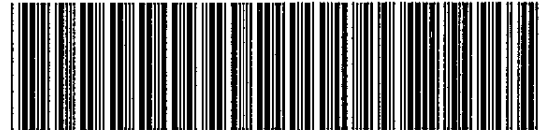

The Limited Liability Company's stated purpose is real estate investment.

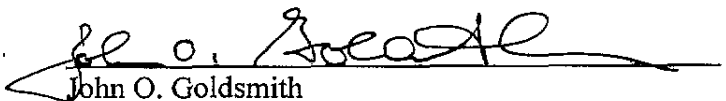
Article 6. Commencement of Existence
