ARTICLES OF ORGANIZATION OF Angie's Salon, LLC

ARTICLE I Name of Company

Angie's Salon, LLC

ARTICLE II Business of Organization

The limited liability company may engage in the business of cosmetology, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III Principal Place of Business

The principal place of business of the limited liability company shall be: 3982 Everett Avenue, Middleburg, Florida 32068, and the mailing address shall be the same.
