ARTICLE I - Name:

The name of the Limited Liability Company is VAN G Holding Company, LLC

ARTICLE II - Address:

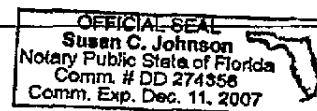
