**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME:

The name of the Limited Liability Company is: RYGAB HOLDINGS, LLC, ("Company").

ARTICLE III - DURATION:

ARTICLE V - ADMISSION OF NEW MEMBERS
