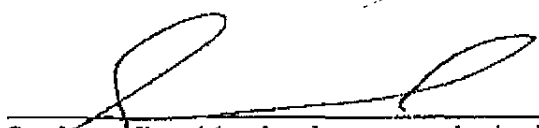
#### ARTICLE VII
