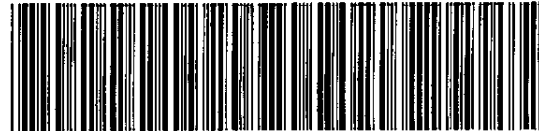

ARTICLE I.

Name.

Written Operating Agreement.

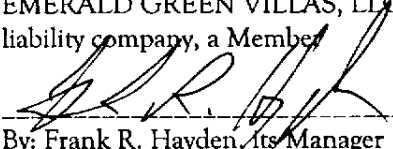

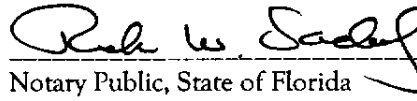

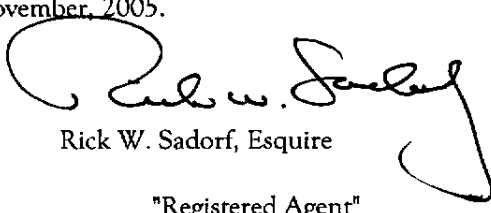
