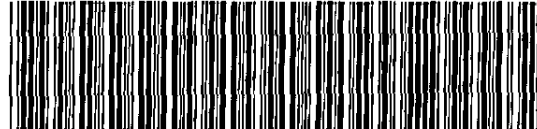

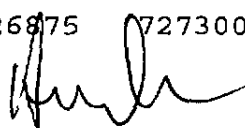

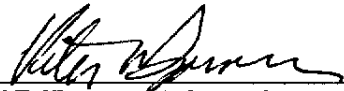
ARTICLE V - Management
