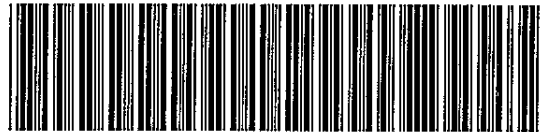

**ARTICLE I**

### ADDITIONAL MEMBERS


