**ARTICLES OF ORGANIZATION
OF
IFF GP, LLC
(a Florida limited liability company)**

The undersigned, being a natural person of the age of eighteen years or more, acting as the sole member of the Company pursuant to Section 608.406 of the Florida Statutes hereby adopts the following Articles of Organization for the Company:

ARTICLE ONE

The name of the Company is IFF GP, LLC.
