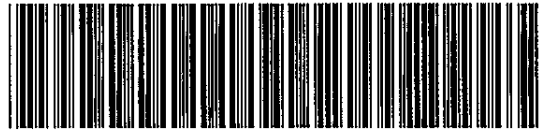

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
ALLISON ADDISON, LLC**

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization were filed on December 1, 2005.

SECOND: The name of the corporation is **ALLISON ADDISON, LLC** (the "Corporation").

THIRD: The following is the amendment to the Articles of Organization which was adopted and ratified by the Members and/or Managers of the Corporation, in the manner prescribed by Florida Limited Liability Company Act:
