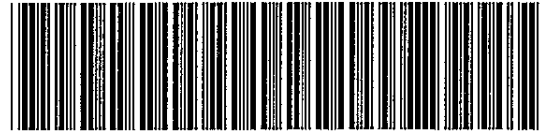

**ARTICLE I - Name**

The name of the Limited Liability Company is:

This Limited Liability Company shall have all powers and authorities as set forth in Florida Statute 608.404 and as hereafter supplemented or amended.

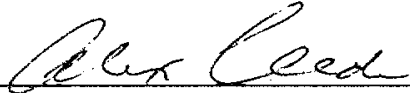
