The limited liability company will continue to exist after the disassociation of a member if the remaining members agree by majority vote to continue the company.

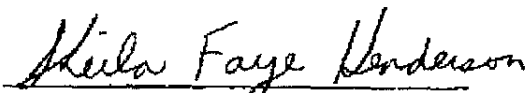
ARTICLE IX MANAGEMENT

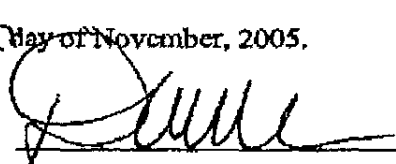

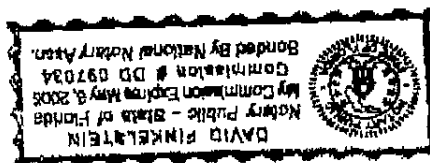
