# ARTICLES OF ORGANIZATION OF THE MASTERS, LLC

The undersigned member(s), or authorized representative of a member, for the purpose of Froming a Limited Liability Company pursuant to Chapter 608, Florida Statutes, hereby adopts the following the following Articles of Organization.

# ARTICLE I - NAME

The name of the Limited Liability Company shall be: The Masters, LLC

# ARTICLE II - ADDRESS

# ARTICLE X - SHARING OF PROFITS AND LOSSES

### ARTICLE XI - VOTING
