**ARTICLES OF ORGANIZATION

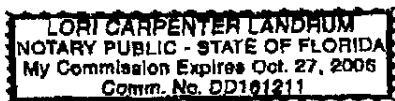


