

ARTICLES OF ORGANIZATION

Each undersigned individual, being either a member of the authorized representative of a member, hereby presents these Articles of Organization to the Department of State of the State of Florida in accordance with Chapter 608, Florida Statues, for the formation of a limited liability company under the laws of the State of Florida.
