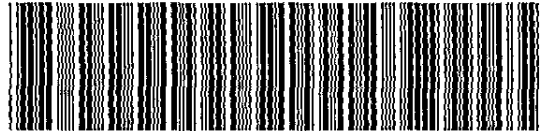

PURPOSE




