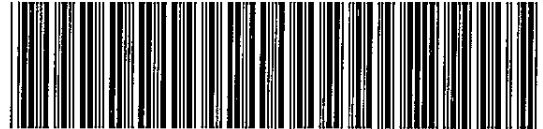

**1 Article
Name**

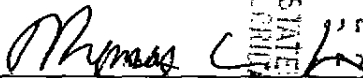
