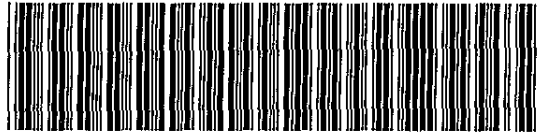



ARTICLE I
NAME
