**ARTICLE VII.**

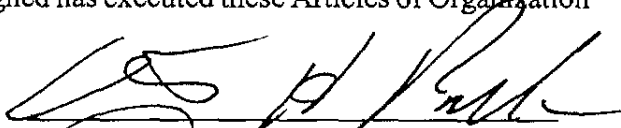
