## ARTICLES OF ORGANIZATION OF SAND DOLLAR PROPERTY MANAGEMENT, LLC

- 1. <u>Name.</u> The name of this limited liability company is SAND DOLLAR PROPERTY MANAGEMENT, LLC, a Florida limited liability company (the "Company").
