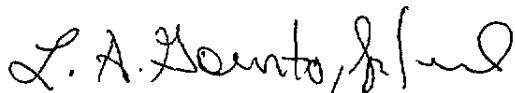

NAME

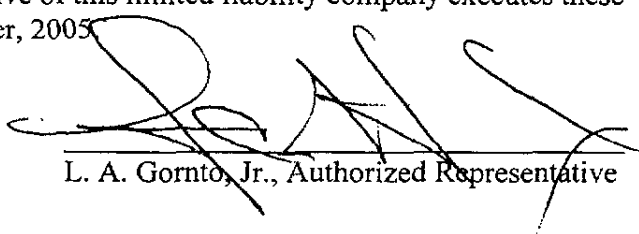

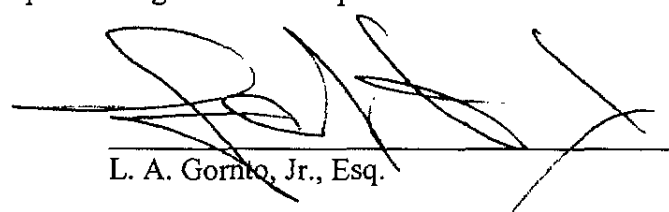
