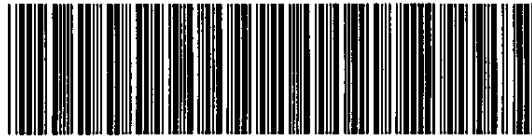

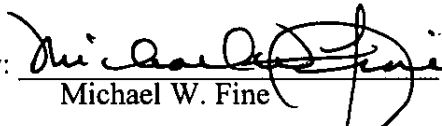
1. The name of the limited liability company is: Priority One Title, LLC.
