**ARTICLES OF ORGANIZATION  
OF  
WAVERLY PROJECT MANAGEMENT, LLC**

1. Name. The name of this limited liability company is **WAVERLY PROJECT MANAGEMENT, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company shall be effective upon the filing of these Articles and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 146 Horizon Court, Lakeland, Florida 33813.

8. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company shall be a manager-managed limited liability company in accordance with the operating agreement adopted by all of the members.
