# ARTICLES OF ORGANIZATION for GARY PHILLIP GAMBLE, PL

The undersigned, for the purpose of forming a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the professional limited liability company shall be Gary Phillip Gamble, PL ("Company").

#### ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 9621 Osprey Landing Dr., Orlando, Florida 32832.

#### ARTICLE III - DURATION

The Company is to exist perpetually.

#### ARTICLE IV - PURPOSE

The Company is formed to engage in every phase and aspect of the practice of Real Estate Agency. In addition, the Company may invest the funds of the Company in real estate mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

#### ARTICLE V - MANAGEMENT

The Company shall be managed by one (1) or more managers and is, therefore, a managermanaged company. Each of the managers shall be of legal age and shall be duly licensed as a Real Estate Agent in the State of Florida. The initial Manager shall be:

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Company is: 1515 International Parkway, Suite 2001, Lake Mary, Florida 32746 and the name of the initial registered agent for service of process at that address is Robert J. Hutchins.

#### ARTICLE VII - MEMBERS

Each member shall be of legal age and shall be duly licensed as a Real Estate Agent in the State of Florida. Further the membership interests of the Company shall be issued only in accordance with the Rules and other pronouncements of the Florida Real Estate Commission or any successor entity.

## ARTICLE VIII - RESTRAINT ON ALIENATION OF MEMBERSHIP INTERESTS

The members of the Company shall have the power to include in the Operating Agreement, or by separate agreement adopted by a majority of the members of the Company, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the membership interests by any of its members, or in the event of death of any of its members. The manner and form, as well as the relevant terms, conditions, and details of the disposition, shall be determined by the members of the Company; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such membership interest. No member of the Company may sell or transfer a membership interest in the Company except to another individual, professional corporation, or professional limited liability company who is eligible to be a member of the Company, and the sale or transfer may be made only after it has been approved at a meeting of the members especially called for that purpose. If any member who is a Real Estate Agent becomes legally disqualified from being a Real Estate Agent in the State of Florida or accepts employment that, pursuant to existing law, places restrictions or limitations on the continuous rendering of such professional services, that member's membership interest shall immediately become subject to purchase by the Company in accordance with the Operating Agreement or other agreements adopted by the members.

#### ARTICLE IX - INDEMNIFICATION

The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.

#### ARTICLE X - EFFECTIVE DATE

The existence of the Company shall commence on December 6, 2005.
