ARTICLES OF ORGANIZATION
FOR
SIX WP BELLE CHATEAU, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of SIX WP BELLE CHATEAU, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I
NAME

ARTICLE II
PURPOSE AND POWERS

The Company shall admit new members as provided in the Operating Agreement of the Company.


**ARTICLE VII
