ARTICLES OF ORGANIZATION OF GARWOOD, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

L NAME AND PRINCIPAL PLACE OF BUSINESS

The several clauses contained in this statement of the general nature of the business 5. or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.

III. EXERCISE OF POWERS

V. MEMBERSHIP RESTRICTIONS

Voting Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with the super majority (75%) written consent of voting members.

or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on the unanimous consent of the remaining voting members.

VL CAPITAL CONTRIBUTIONS

Capital contributions in the form of cash or real property having a value of \$500.00 shall be contributed to the limited liability company by the Members in equal shares.
