## ARTICLES OF ORGANIZATION OF CAY 777 PASADENA, LLC

- 1. NAME. The name of this limited liability company is CAY 777 PASADENA, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
