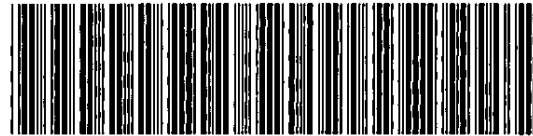

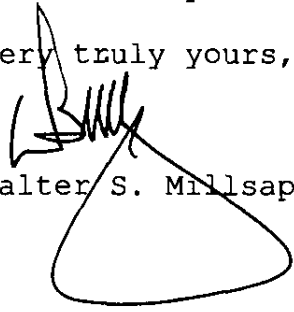

1. The street address of the principal office of the Company as well as the mailing address is 13509 Princess Kelly Drive, Jacksonville, Florida 32225.

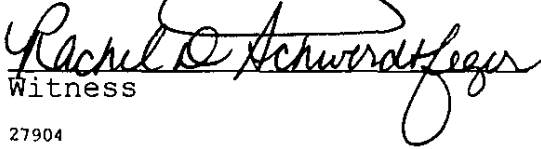
