ARTICLES OF ORGANIZATION OF JULINGTON, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I: Name The name of the limited liability company is JULINGTON, L.L.C. (the Company).
