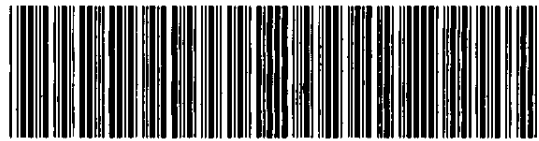

I am in the process of deciding if I will take legal action to this regard.

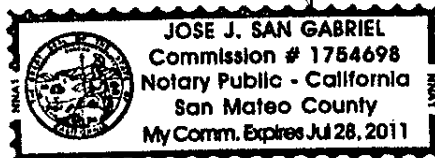



Mr. Mendoza:

As June 2008 I resigned as president of GCS Solutions LLC, position that you took.

From that date you took control managing the company due to an agreement we both made in which you will pay me back all the expenses incurred in your personal maintenance (you were living at my house and supported through my credit cards and loans) and those of the company you were responsible of, including loans I took on my name to support the company (in all totaling \$245,535). Also, you agreed to pay GCS's providers and creditors from money gain for the business activities.

As of today, you have not paid me back neither fulfillment your agreement of paying suppliers nor financial institutions even though you had receipt money from the company's earnings. These actions have dramatically affected me both financial and personal.

Now, I became aware that a report has entered into the Florida Department of State Division of Corporations on September 1<sup>st</sup> 2009 removing your name from the company and entering my name without my knowledge neither my consent. Also, the report is signed by someone pretending to be me. These actions have serious consequences; the source of a public report could be easily traced.

I did NOT enter, I did NOT sign the report mentioned above and want to formalize my resignation to GCS Solutions LLC. as of June 2008.

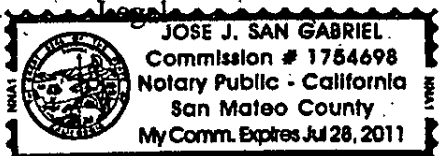
