The undersigned hereby certifies that it has formed a limited liability company under the State of Florida.

ARTICLE I Name

The name of the limited liability company shall be TMAC MEDIA, LLC.

ARTICLE II Address and Place of Business

- Transact any lawful business which the Members or the managers find to be in aid (m) of governmental policy.
- Pay pensions and establish pension plans, profit-sharing plans and other incentive (n) plans for any or all of its managers and employees.

ARTICLE VI Registered Office and Registered Agent

ARTICLE X Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the business of the limited liability company shall not cease and the limited liability company shall not be dissolved unless the business of the limited liability company is terminated by the consent or agreement of the majority of the remaining Members interests.
