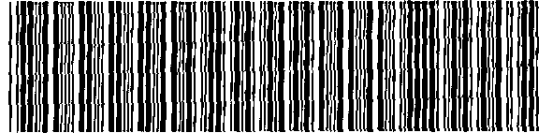

## **ARTICLE VII**


### **Death, Retirement, Expulsion, Bankruptcy or Dissolution of a Member**


