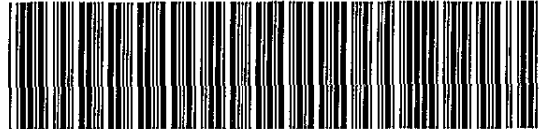



The name of this Limited Liability Company is HARD ROCK ENGINEERING, LLC. (hereafter referred to as the "Company").


ARTICLE II
