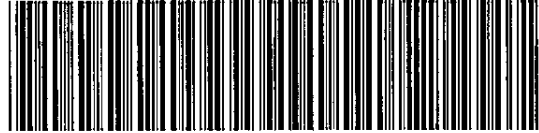

(Name and Principal Place of Business)

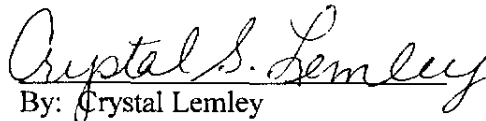
**ARTICLE VI**

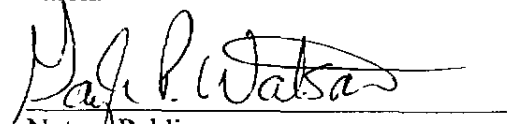
