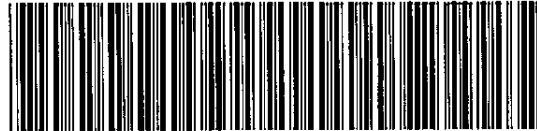

**ARTICLES OF ORGANIZATION  
OF

The undersigned, desiring to form a limited liability company under and by virtue of the laws of the State of Florida and specifically pursuant to the provisions of Chapter 608, *Florida Statutes (2005)*, does hereby execute these Articles of Organization.

**ARTICLE I  
NAME AND PRINCIPAL OFFICE**

The name of the Company shall be **ALLEN PLANTATION, LLC**, and its principal office and mailing address shall be 1151 North Orange Avenue, Winter Park, Florida 32789.

**ARTICLE II  
REGISTERED AGENT**

The name and street address of the initial registered agent and registered office of this Company shall be **PHILIP TATICH**, 1151 North Orange Avenue, Winter Park, Florida 32789.

**ARTICLE III  
COMMENCEMENT DATE AND TERM OF EXISTENCE**

This Company shall have perpetual existence which shall commence upon the subscription and acknowledgment of these Articles of Organization.

**ARTICLE IV  
MANAGEMENT OF THE COMPANY**

This Company is to be managed by one or more managers and is, therefore, a manager-managed company. The initial Manager of the Company shall be Howard B. Lefkowitz.
