**ARTICLES OF ORGANIZATION
OF
ASHFIELD ESTATES, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE 1 – Name: Ashfield Estates, LLC (the “Company”).


