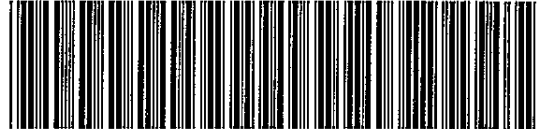



NAME




