ARTICLES OF ORGANIZATION

OF

SPRING TECHNOLOGIES OF FLORIDA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be <u>SPRING TECHNOLOGIES OF</u> <u>FLORIDA, LLC</u> ("Company").

ARTICLE II - ADDRESS

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferse shall have no


ARTICLE IX - INDEMNIFICATION AND LIABILITY
