#### ARTICLES OF ORGANIZATION OF KUBIK NO. 1123, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, Florida Statute 608 F STATE Florida Limited Liability Company Act, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
