# ARTICLES OF ORGANIZATION OF

The undersigned certify that we have associated ourselves together for the purpose of 12 p 12: becoming a limited liability company under the laws of the State of Florida, Florida Statute 608, 5 RY OF STATI immunities of limited liability companies for profit. We further declare that the following Articles SEE, FLORIT shall serve as the Charter and authority for the conduct of business of the limited liability company.

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, company, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.
- 5. To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or companies, and perform any service

Members shall have the right to admit new members by unanimous consent Confributions, FSTATE required of new members shall be determined as of the time of admission to the limited liability, FLORIDA company.
