ARTICLES OF ORGANIZATION

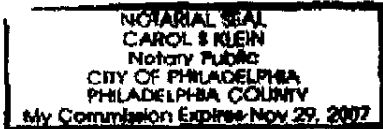


