**ARTICLES OF ORGANIZATION
OF
MEASURELESS INVESTMENTS, L.L.C.**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

MEASURELESS INVESTMENTS, L.L.C.

SECOND: The latest date on which the Limited Liability Company is to dissolve is December 31, 2039.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The mailing address and street address of the initial registered office of the Limited Liability Company in Florida is Attn: Ondina E. Laszlo, 13711 S.W. 37th Terrace, Miami, Florida 33175 and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Ondina E. Laszlo.

FIFTH: The mailing address and principal office of the Limited Liability Company is 13711 S.W. 37th Terrace, Miami, FL 33175.

SIXTH: The Limited Liability Company shall be managed by a Managing Member. The name and address of the initial Managing Member is: ONDINA E. LASZLO having an address at 13711 S.W. 37th Terrace, Miami, Florida 33175.

SEVENTH: The total amount of cash, and a description and agreed value of any property other than cash, contributed to the Limited Liability Company, as capital, by the Members is Two Hundred Thousand Dollars (\$200,000.00). The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

EIGHTH: Additional capital contributions may be made as such times and in such amounts as may hereafter be agreed by the unanimous vote of the Members. No additional capital contributions have been agreed to by the Members at this time.

ELEVENTH: The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members, (other than the Managing Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

TWELFTH: None of the Members of the Limited Liability Company shall be liable for the payment of any debt, obligation or other liability of the Limited Liability Company.

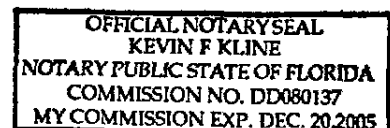
